While fundamentally an indirect tax measure, the SST Expansion has far-reaching implications. Businesses across sectors must reassess their operations, including procurement strategies, supply chain management, legal frameworks, and compliance protocols including rules for claiming exemptions to ensure compliance with the new regulations.
