What do we do now?

The government has recently announced that the reduced of GST rate from 6% to 0% on all goods and services supplied effective 1 June 2018. GST Amendment Order and Revocation Orders were gazetted to effect the change in the GST rate.

Does it mean that no GST payable after 1 June 2018?

How are businesses impacted from the announcement? How or what businesses should do from now till 31 May 2018? Can GST registered persons still be able to claim input tax credits during this taxable period?

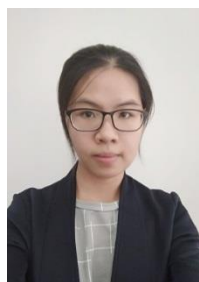
