

DISRUPTION IN CERTAIN TAX PAYMENT CHANNELS

The Inland Revenue Board (IRB) has issued a media release on 16 December 2022 informing that the IRB is in the process of upgrading their internal system which is expected to be completed on 1 January 2023.

To ensure a smooth upgrade process, certain tax payment channels will be temporarily closed. The last date of acceptance of payment for the respective tax payment channels and its re-opening date are as below:
